SECURE ENERGY SERVICES ANNOUNCES THE RESULTS OF THE 2013 ANNUAL AND SPECIAL MEETING OF SHAREHOLDERS

CALGARY, ALBERTA May 10, 2013 – Secure Energy Services Inc. (the "Corporation") (TSX – SES) is pleased to announce that all of the nominees listed in the management proxy circular dated April 4, 2013 were elected as directors of the Corporation at its annual and special meeting of shareholders held on May 9, 2013 (the "Meeting"). In addition, each of the other items of business considered at the Meeting, namely: (i) the re-appointment of MNP LLP, Chartered Accountants as the Corporation's independent auditors, (ii) the approval of amendments to the Stock Option Plan of the Corporation, (iii) the approval of the Performance Share Unit and Restricted Share Unit Plan of the Corporation, (iv) the approval of the amended by-laws of the Corporation, and (v) the non-binding "say on pay" advisory vote approving the Corporation's approach to executive compensation, were all approved at the Meeting.

division offers a wide range of services including pipeline integrity (excavation, inspection, repair, replacement and rehabilitation); remediation and reclamation; demolition and decommissioning; asset recovery; and environmental construction.
